

# **ITEM NO.307.10**

Sub: Performance Evaluation Report (PER) of Subsidiaries' MoU of CIL for the year 2021-22.

- 307.10 In respect of the captioned proposal, Director (Technical) apprised the CFDs as under:-
  - 1. DPE vide Online MoU Dashboard, evaluated the MoU Performance for the FY 2021-22 & displayed the score & rating of CIL's consolidated MoU-FY 2021-22 as "80.89 & Very Good" respectively.
  - 2. Subsequently, subsidiaries were asked to submit the self PER of Subsidiaries' MoUs FY 2021-22 as per signed MoU between CIL and subsidiaries duly approved from respective FDs.
  - 3. Upon submission, respective PER along with all relevant back-up documents were put up to the Committee constituted dated 17.01.2023 at CIL for verification/validation in accordance with the DPE performance evaluation of the CIL's consolidated MoU FY 2021-22.



- 4. Committee Meetings were held for deliberations & finalization of Scores & Ratings. The Sub-Committee, under Committee, assisted in verification/validation of the respective PER of subsidiaries and PER of respective subsidiaries were deliberated at length and slippage in rating was observed for SECL, BCCL & WCL.
