


5. SELECTION PROCESS (Computer Based Test)

- a. The Selection methodology will comprise of Computer Based Test (CBT) only. No personal interview will be held.
- b. Eligible Candidates will be provisionally called for Computer Based Test (CBT) on the basis of their declaration regarding their eligibility such as age, educational/technical qualification, Valid Statutory Certificate etc. as laid down in this notification/advertisement. The scrutiny /verification of the claims made by the candidate supporting their eligibility for the post applied will be done post declaration of results of Computer Based Test (CBT) for the candidates who have been called for document verification process. Merely appearing in CBT based on declaration of the candidates will not entitle them for further scrutiny in the selection, if any discrepancy is found in the eligibility criteria and declaration submitted by applicants.
