


In inviting a reference to your letter No. 6280/SM Dt. 21.06.2023 on the subject cited above, I am directed to say that your proposal for vacant posts through Direct Recruitment under the administrative control of Director of Mines & Geology has been verified as per the ORV Act, taking into consideration the Post-Based Reservation Principle presently in force and 50% limitation on reservation imposed i.e ST-22.50%, SC-16.25% & SEBC-11.25% by the Hon'ble, Supreme Court of India and it is found that Sl.
