

SELECTION PROCESS

Written Test:

The Written Test shall be of Objective type (each question shall have four options) of two hours duration consisting of two parts –

- (a) Part-I consists of Technical/Professional Knowledge Test (TKT/PKT) with 120 questions having specific questions from respective discipline.
- (b) Part-II consists of Aptitude Test (AT) with 50 questions on vocabulary, verbal comprehension, quantitative aptitude, reasoning ability, data sufficiency & interpretation, numerical ability etc.

All questions carry equal marks (1 mark). Wrong & multiple answers would result in negative marks of $\frac{1}{4}$.

Qualified candidates shall be called for the Trade Test as per merit in the ratio of 1:5 for vacancies up to 3, 15 for vacancies of 4 and 1:3 for 5 or more vacancies advertised in any category for this post. The number of candidates called for Trade Test may change as per availability of suitable candidates at cut-off.

Trade Test:

The Trade Test will be Qualifying in nature. Qualifying marks in Trade Test shall be 40% for Unreserved/ EWS and 30% for reserved category candidates if posts reserved for the respective category. Trade Test marks shall not carry any weightage in final merit.

Empanelment:

Those who qualify in the Trade Test shall be empaneled in order of merit as per their marks obtained in the Written Test. Final merit for selection will be decided based on marks secured by the candidates in Written Test through Computer Based Test (100% weightage) subject to qualifying in Trade Test. Candidates who will qualify as per qualifying criteria shall be shortlisted category-wise for empanelment, in proportion to the number of vacancies in the respective category.

Offer of appointment:

The offer of appointment shall be issued to the suitable candidates empaneled in the order of merit and based on the requirement. Appointment of selected candidates will be subject to their being found medically fit in the Pre-Employment Medical Examination to be conducted as per <u>POWERGRID</u> <u>Norms and Standards of Medical Fitness.</u>

Date of issuance of final mark sheet shall be taken as the date of acquiring qualification.
- 4. Fill up other details in the application very carefully. Please take care while filling out the email/ alternative email fields since all important communication shall be through emails only.
- 5. Candidates should ensure the following while filling up the online registration form:
 - Qualification details are complete.
 - Complete Details of experience are mentioned separately for each organization along with pay details, if applicable.
